

Historic Jackson Ward Association Public Meeting Minutes September 18, 2018

The HJWA Public Meeting was held in the UNOS conference room at the Jackson Center at 501 North 2nd Street. Members in attendance were:

Janis started the meeting at 6:05pm and thanked people for coming out despite the foul weather.

### **Richmond Police Report**

Environmental Officer Frank Mizziano presented.

He discussed the crime statistics in the neighborhood. In general, crime had gone down significantly since the last crime report from RPD. There was a 43% decrease in theft from motor vehicles which is generally the most widely reported crime in the neighborhood. All other crimes were down in varying degrees. As usual, he cautioned residents to not leave valuables in cars or their car or home doors unlocked.

In response to a question from Jay Som, Officier Mizziano noted that many of the suspects in the past were being arrested. One person confessed to many of the crimes that had been committed on St. James.

# **VCU Police**

Greg Felton talked about addressing many of the party houses in the area recently. He noted in particular houses on Chamberlain and Leigh, West Clay, East Clay, and West Jackson.

Captain Butters joined Officer Felton and spoke about recent developments with the VCU Police jurisdictional expansion into Jackson Ward. According to Chief Venutti of VCU Police, the finish line for the implementation is close and likely to come to fruition.

Both officers also touched on a rash of burglaries in Carver and the Fan, robberies with an MO of going through unlocked backdoors. They cautioned people to keep their backdoors locked and reminded folks to keep car doors locked as well.

In response to a question regarding graffiti, Officer Felton noted that quick removal is key to minimizing graffiti long term.

## Tito Luna

Tito Luna from VCU discussed the Master Plan for VCU's recent acquisition of property at Belvedere and Leigh. VCU is currently trying to reschedule one of the talks which was cancelled due to hurricane

The current plan for the space looks like it will be going to VCU's Department of Recreational Sports, the department that's in charge of gyms and club sports. Currently, this department is in need of more field space and group exercise as current VCU gyms are over capacity with the recent decision to allow any community member to join.

Tito stressed that he doesn't know the exact nature of what the property will look like. He imagines that, at the very least, some equipment storage will go there

Captain Butters noted that, if the space becomes one frequented by students, VCU Police will increase their presence there.

The two representatives from Venture Richmond presenting passed out two documents related to the upcoming 2nd Street Festival, the 30th year of the festival. Those sheets contained significant relevant information, and as such these minutes will not include it here.

There will be significant street closures in the neighborhood starting Friday (see sheet for details). Note: the street closure dates on the sheets are inaccurate, although the clerical error isn't terribly confusing. These closures will last until approximately 10:00pm Sunday evening, reopening once the street has been cleaned and cleared.

The presenters noted that event parking for those helping run the event will be at the fenced lots near 533 and also near Maggie Walker Place. They commended Janet Armstead for trying to get parking passes for residents.

Gary Flowers noted that, due to the 30th anniversary, he was attempting a "renaissance role call," trying to summon organization and their members that were instrumental in the festival.

The Venture Richmond presenters ended with a history lesson on the origins of the Festival. Namely how, 30 years ago, the Valentine did a documentary on Jackson Ward. They came to Downtown Presents (the precursor to Venture Richmond) and did an outdoor presentation of the documentary at the Hippodrome, an event which turned into a block party. The next year, a celebratory event expanded. Presenters found a picture from that first event.

## Clean up day (October 20, 8am)

VCU had planned on doing a neighborhood cleanup on September 15; however, that event was rained out. The new plan is to invite them to join HJWA for our already scheduled Fall Clean Up Day which will take place on October 20 at 8:00am.

### **Parking Permits**

Jim Vigeant had asked Janis to collect names of those folks who were in support of the parking permit plan. Janis asked who was working on getting names for their blocks; no one in the meeting was. For those interested in collecting names, a petition is on the HJWA website for download.

There will be more discussion when Jim returns (who's currently on vacation), as he seems to be leading the charge.
